



## Practice of Professional Supervision Workshop

The AOTI and IASLT are pleased to announce a HSE funded Professional Supervision workshop.

This course is designed to train **15** OT and SLT therapists in the Practice of Professional Supervision. Applicants **must** be in a position to attend all four days of this workshop.

### Practice of Professional Supervision for Current Supervisors – Four Day Workshop

This course is designed for OTs and SLTs who are currently supervising staff. The workshop is for four full days. Participants attend two days and then a further two follow up days 4-6 weeks later. Participants are given activities and tasks to complete between the first and second workshop sessions. Workshops include a mix of teaching, discussion, exercises, interaction and practice. A strong emphasis is placed on experiential and interactive learning. The target audience is senior and manager therapists who provide supervision in their clinical practice.

#### Course Aims:

To provide participants with an understanding of the purpose and functions of professional supervision in the context of their work and to develop supervision skills.

#### Workshop Facilitator:

Eileen O'Neill is the workshop facilitator. Eileen O'Neill is a leading expert in the area of Professional Supervision in Ireland and has published extensively on the topic.

#### Course Content:

- Theory around Professional Supervision (What is Professional Supervision, Importance of Supervision, Functions of Supervision, Challenges of providing or engaging in supervision)
- Developing skills necessary for effective supervision

- Analysing current challenges in relation to supervision and developing strategies with regard to addressing same
- Frameworks and policies for professional supervision
- Developing action plans for how to implement training into practice

### **Who can apply?**

- OT and SLTs of all grades
- Members and non-members of AOTI and IASLT are welcome to apply
- As this is HSE funded training, priority will be given to OTs and SLTs working in the publicly funded Health Service.
- Places will be allocated on a first-come first-served basis, however applications will be reviewed to ensure they meet criteria.

### **Registration fee:**

Funding for this course will be covered by the HSE. However there will be a non-refundable booking fee of €20 in order to secure a place. Please do not submit payment until your place has been confirmed.

- 1) Managers **must** approve applications prior to applications being made.
- 2) Applicant's current practice area must match the aims of the training.
- 3) Attendance at the training event must impact your current practice.
- 4) All applicants must work in the publicly funded health service.
- 5) Members and non-members of IASLT can register attendance.
